

Is Same Sex Marriage Legal?
The Supreme Court Will Soon Decide.

Interpreting the Constitution Is Tricky Business That Is Why We Have a Supreme Court

Stanley Harrell had the program last week. His guest speaker was Herb Phillips, retired superior court judge. Judge Phillips' talk centered around two Constitutional Amendments—the First Amendment that guarantees freedom of religion, speech, free press, and the right of assembly and petition; and the Second Amendment that gives citizens the right to keep and bear arms. Much to everyone's chagrin, few Rotarians knew what was included in the amendments. Judge Phillips explained that the constitution is a living document and can be changed as circumstances warrant. However, it must be interpreted as it is written until such time as changes are initiated and passed by congress... which is oftentimes difficult.

Judge Phillips gave several examples of court cases that illustrated how difficult it is sometimes to apply the constitution to specific cases. Take for example a student who wears a black ISIS armband to school. Can the student be made to remove the band or is he protected under the freedom of speech amendment? Or take the case of same sex marriage. Do couples have a right to marry anyone they please under the Fourteenth Amendment? It gets complicated, doesn't it?


